## 2026 Power Wheel Bump & Run Entry and Release Form Event Rules:



### Classes

- 2-3 years (with or without parental remote control)
- 4-6 years (6 volt or 12 volt)
- 7-9 years (6 volt (18/20/24 Volt))

- Sit in vehicles only, no tractors, motorcycles or 4 wheelers. Remember the vehicles may bump into each other.
- Must use 6 volt, 12-volt, 18, 20 or 24-volt battery only and must be mounted secure and covered with rubber mat, not in the passenger seat. Stock battery can be replaced.
- Vehicles must have doors/tailgates taped shut, no reinforcement or added metal.
- All children must be signed in with one parent at the pit gates.
- All children must wear approved safety helmets. Bicycle helmets are acceptable
- Shoes or sneakers required, no open toed shoes.
- If child gets out of the power wheel during event, that child is out of the event.
- **Power Wheel Build:** All power wheel must remain stock with no added reinforcements. You may add a rubber tire to the tread area of the power wheel's tire for added traction or wrap the tire in duct tape to prevent cracking. No raising or lowering of front or back. **No added reinforcement allowed.**
- **Power Wheel Décor:** Power wheels may be decorated but can NOT reinforce. Decoration can only be made out of the following: cardboard, tape, paper, etc.
- Each power wheel must have a number on one side for scoring. (CCS will supply numbers & balloons)
- Keep in mind this is for fun for children!
- Each age group will be given a time limit max 10 minutes. 1 Parent will be allowed in the pit area with their child during the event.
- Two pit passes (1 for child, 1 for parent) will be provided.
- All power wheels will be checked in at pit gate, and then impounded until time for the event
- The winner will be decided by the child that performed the best during the event or is the last driver with a balloon attached to their power wheel.
- Each class will be awarded 1<sup>st</sup>, 2<sup>nd</sup> & 3<sup>rd</sup>.
- In the event of rain, the Power Wheels Demo Derby will be canceled and not rescheduled.
